Tudi v nadalje ostajam na voljo in vas prijazno ter s spoštovanjem pozdravljam,

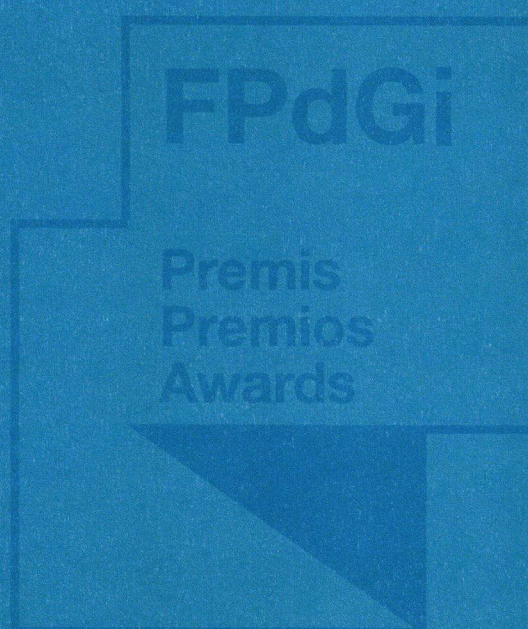

# THE PRINCESS OF GIRONA FOUNDATION INTERNATIONAL AWARD

**The FPdGi presents its International Award with the aim of recognising the professional and personal careers of young people in any part of the world who stand out for their work, their merits and their exemplarity. The impact must always be considered in its broadest dimension, in that their contributions extend and/or are known on an international level.**

This global award highlights the capacity for achievement and self-improvement of young people from all over the world in the development of projects — especially when they have involved difficulty or risk — demonstrating that they have the power to influence positive changes in society in a creative way and that they are inspiring role models for other young people.

## WHO CAN PRESENT NOMINATIONS?

**Nominations for the Princess of Girona Foundation International Award can be made by:**

- > Winners of previous editions of the Foundation's Awards in any of the categories, as long as they are not also members of the jury for this International category.
- > Trustees, members of the Advisory Council and members of the juries for the Princess of Girona Foundation Awards.
- > Spanish embassies.
- > Diplomatic representatives in Spain.
- > People and institutions invited by the Princess of Girona Foundation.

Nominations can be endorsed by more than one person or institution – see page 2 'Endorsements'

This award is specifically designed for non-Spanish nationals who carry out their professional activity outside Spain.

### **Candidates must:**

- > Be between 16 and 35 years old before the deadline for presenting nominations, i.e. candidates born **between 1 December 1984 and 30 November 2004.**

### **HOW, WHEN AND WHERE CAN ENTRIES BE SUBMITTED?**

Before **23.59h on 30 November 2020.**

This is a global award aimed at recognising young people not living in Spain. Young Spaniards (including those with dual citizenship) and those resident in Spain can present their candidacies in the individual categories of the FPdGi Awards: Social, Business, Arts and Literature and Scientific Research.

The jury meetings will take place in the first half of 2021.

# INTERNATIONAL AWARD

The FPdGi International Award recognises the professional and personal careers of young people in any part of the world who stand out for their work, their merits and their exemplarity. The impact must always be considered in its broadest dimension, in that their contributions extend and/or are known on an international level.

## EVALUATION CRITERIA

### 1. EXEMPLARITY (This is an exclusionary criterion)

- > We are seeking a candidate who has demonstrated an extraordinary capacity for leadership and influence.
- > They must be an inspiration to other young people for their values and ethical behaviour, as well as their tolerant nature and creativity.
- > The candidate must stand out for their capacity for achievement and self-improvement in the development of projects, especially when they have involved difficulty or risk.

### 2. DIFFERENTIATION

- > The candidate's career should have distinctive characteristics based on their talent, their work or projects or their capacity to overcome great difficulties.

### 3. IMPACT

- > The candidate must stand out for their renown and innovative character, reflected in their work and projects which have the capacity to provide tangible and significant achievements.
- > They must lead the way in the continuous search for excellence.
- > The impact must always be considered in its broadest dimension, in that their contributions extend and/or are known on an international level.

## 4. GLOBALITY

- > A positive view will be taken of projects that have demonstrated multifunctional or global influence, either as recognition of the work carried out, or the application of the knowledge developed.

## PRESENTATION OF NOMINATIONS

**Nominations can be submitted any time before 23.59h on 30 November 2020.** Entries will only be accepted as valid if submitted using the FPdGi International Award nomination form available from the website [www.fpdgi.org](http://www.fpdgi.org)

When submitting the nomination form, people nominating the candidates must obtain prior acceptance of these rules and a guarantee, will full indemnity for the Foundation, of the accuracy of the information included in the entry, as well as the ownership and exploitation rights vis-a-vis third parties of all graphic materials, trade names and other information provided in the entry form, which may be used by the FPdGi to publicise the awards or award winners.

## ENDORSEMENTS

**Nominations can be accompanied by additional endorsements in supporting letters**

These endorsements in the form of a supporting letter can be written by those in charge of representative organisations and institutions such as universities, local councils, chambers of commerce and other public and private institutions of recognised prestige, as well as trustees of the Princess of Girona Foundation and the members of its Advisory Council.<sup>(1)</sup> It is possible to endorse more than one candidate.

These letters should be attached as a file to the nomination form.

## Information that will form part of the evaluation

The nomination form must be completed in English. The jury will not take into consideration any information other than that presented in the nomination form or attached to it when it is submitted.

The Foundation may request additional information from the entities or people nominating candidates if necessary.

**The presentation of a candidacy nomination form automatically implies full acceptance of these conditions of entry by the nominating person or entity and the candidate. The candidate can do this when the form is submitted or, if applicable, on winning the award. Acceptance of these conditions is an essential requirement for receiving the award.**

The people or entities presenting candidates and the winning candidates grant their express consent for the publication of the information provided in the entry form, including their photographs, and images of the project if chosen as winners.

## INFORMATION INCLUDED IN THE FORM AND PERSONAL DATA

Pursuant to the provisions of the General Data Protection Regulation (EU) 2016/679, we hereby inform you that we will process your data solely for the candidate selection procedure performed by the organisation. This process requires your express consent to publish the information provided in the application form, including your photograph, and also the presentation video and images of the project if it is one of the prizewinners. The Princess of Girona Foundation reserves the right to disseminate information related to the prizewinners in each of the categories, in whatever manner it considers

appropriate. We inform you that we will use your data only for the FPdGi International Award Category selection procedure; your data will not be shared with third parties without your consent. We also inform you of the possibility of exercising the following rights concerning your personal data: right of access, rectification, erasure (right to be forgotten), restriction, objection, portability, and right to withdraw consent after it has been given. ## CONSENT

We will process your data solely for the candidate selection procedure carried out by the organisation. Check the box below to accept this purpose. ## JURY FOR THE AWARDS

The Princess of Girona Foundation Awards have a specific international jury for this award, composed of between five and eight members who either serve on the FPdGi Advisory Council, or are external experts, as well as winners of previous editions of the FPdGi Awards in any of the categories.

The ultimate decision regarding the winning candidate will be taken by simple majority. This must be supported by solid arguments and will be considered final.

Members of the jury cannot endorse candidates for this award. In the event of any other conflict of interests that may arise in relation to any member of the jury, this person will abstain from debating and voting.

The jury may decide not to award the prize if it considers that none of the candidates nominated meet the requirements or aims of the award.

The jury will interpret and supplement the conditions of entry for this award to cover any gaps or resolve any issues that may arise.

The vote of each member of the jury may not be delegated and must be cast in person at the moment the vote is held.

## SPECIFIC CONDITIONS FOR THE WINNERS

Attendance at the award ceremony cannot be delegated.

The award winners agree to participate in the communication actions organised by the Foundation in connection with the award.

### AWARD CEREMONY

The date of the award ceremony will be announced at the appropriate time.

The award consists of a reproduction of a work by the Spanish contemporary artist Juan Zamora, FPdGi 2017 Award winner, and a cash prize of €20,000.
